

The Valley Outdoor Association (VOA), formed in 1973, sponsors hiking, snowshoeing, natural history, back packing and cycling. The VOA offers all these activities for an annual membership fee of \$35 Single and \$55 Family due October 1. Membership purchased after June 30 is carried through the following year. A quarterly schedule of activities is mailed to all members. Each weekend, year round, we offer 2 or 3 different trips. While most are day trips of varying difficulty, we also plan weekend and longer ones. The VOA holds 4 evening meetings a year in Surrey – refer to the VOA bulletin for date and location. A slide show or guest speaker usually follows a short business meeting.

The VOA is a member of the Federation of Mountain clubs of BC (FMCBC). Through this membership we have a voice in provincial hiking and mountaineering policies. Outdoor Skills courses in avalanche safety, mountaineering, etc are periodically offered to members.
